



#### Drug Overdose Deaths Per 100,000, by Race/Ethnicity





 Prevalence of OUD increased 333% from 1.5 cases/1,000 delivery hospitalizations




# Colorado Overdose Deaths: 2000-2019

Figure 6: Overdose Death Rates Per 100,000 People in Colorado by Race/Ethnicity, 2000–2019





#### 6 Levels of Service




- 24/7 walk-in/care availability

- 24/7 provider coverage in multiple areas



### General Program Information

- Offering two levels of Substance Use Disorder Treatment
  - ASAM 3.7 Level of Care Medically Monitored Intensive Residential Treatment
  - ASAM 3.5 Level of Care Clinically Managed Intensive Residential Treatment
- 16 Bed Facility that serves clients age 18-65
  - 8 double occupancy rooms
- Designed for individuals with co-occurring substance use and mental health disorders
- Length of stay will be determined by medical necessity
- Home-like setting where clients will participate in cooking, laundry and other skill building activities of daily living



#### Services Provided

- Each client will participate in at least 20 hours of individualized treatment a week
- Evidence Based Group Therapy
- Individual Therapy
- Opportunities for Family Therapy/Support System Therapy
- Recreation Therapy on-site gym
- Medication Assisted Treatment
- Substance Monitoring




