





- Lower-cost care options and freestanding services (e.g., ambulatory surgery, lab, imaging)
- Community-based rates at new hospitals and ambulatory sites
- Primary care expansion and focus on prevention
- Virtual health solutions including virtual visits
- Integrated behavioral health
- Population health and value-based care initiatives
- Narrow network offerings that often include double-digit discounts
- Employer solutions

THE CHANGING LANDSCAPE



Recent and developing trends in health care

TRENDS STILL HERE POST-COVID

Push for increased affordability

Growth in nationwide health care costs continues to place pressure on care providers to reduce costs and find new delivery models (e.g., value-based care).

Demand for price transparency

Pressure to increase price transparency led to new federal regulations that require hospitals to provide prices for 300 shop-able health care services.

COVID ACCELERATED TRENDS

Shifts from inpatient to outpatient

The shift of care away from inpatient settings was accelerated by COVID-19, with uncertainty that the volume will return.

Increased adoption of telehealth

Adoption of telehealth increased significantly due to COVID-19; 46% of U.S. consumers reported using telehealth in the spring of 2020, up from 11% in 2019.

DEVELOPING TRENDS MOVING FORWARD

Rising patient expectations

Consumers have grown to expect high-quality experiences from their service providers and demand the same from their health care providers.

Payer pressure and competition

Payers continue to deploy strategies to limit health care spend, control more of the premium dollar and explore opportunities for vertical integration into care delivery.

Disruption from new entrants

Growth of investments in emerging technologies and companies threatens to disrupt traditional healthcare delivery models.

Federal and state legislative pressures

Health care remains a top priority for both our federal and state legislatures with a emphasis on health care costs and affordability.

Health equity and health disparities

There has been an increasing focus on health inequities and health disparities. Health systems will need to identify ways to impact and measure progress.



Health care trends and recent activities in Colorado

- Substantial focus of the state legislature on health care affordability and financial performance of hospitals (eg. Colorado Public Option, 15% reduction of insurance premiums 2023-25)
- Significant expansion of Optum across multiple care types and settings (primary care, orthopedics, ASC, ACO)
- Co-ops and purchasing alliances (e.g., Peak Health Alliance) are attempting to amalgamate municipalities and employer groups to increase leverage, reduce rates and drive affordability
- Shift in perception toward a more sympathetic view of health plans and more negative view of hospitals and health systems
- While there was a period of limited activity, there has been additional hospital and provider consolidation as of late (e.g., Intermountain and SCL merger)
- New primary care market entry with Village MD/AFM merger
